



Q. Who do you think won the presidential election?







Among Those Who Think Trump Won, Even After Stated Facts, Views About Election Are Unchanged; More Say Resist Legal Process Than Respect It

Q. Following the presidential election, Donald Trump alleged that there was massive voter fraud and filed several lawsuits to stop states from awarding their electoral votes to Joe Biden. The Trump campaign had its day in court and lost nearly all these cases. State officials — both Republicans and Democrats — certified Joe Biden as the winner in the most closely contested states after finding no evidence of large-scale fraud or errors in the vote count. On January 6th, Congress met to count the electoral votes and affirmed Joe Biden's election.

Whether or not you agree with these decisions, would you say that Joe Biden was legally elected as President, or not? [Asked of Those Who Thought Trump Won the Election]





Q. Do you think the goal of politics is more about...?



Q. Would you be more or less likely to vote for a candidate for office who did each of the following in connection with the unrest at the U.S. Capitol Building?





More Support For Barring From Public Office Than Conviction


Q. Following the unrest at the Capitol on January 6, 2021, do you support or oppose Donald Trump being...?





3 In 10 Republicans Support Barring Trump From Future Office





GOP Support For Trump Over Party Steadily Trending Down


Q. Would you say you consider yourself to be primarily a supporter of Donald Trump, or a supporter of the Republican Party? [Asked of Republican+Lean Voters]





Support For Trump 2024 Falling Among Both Voters & GOP




Trump +7 If Presidential Primary Held Today
